

## Mind, Body + Sol Sweepstakes

### OFFICIAL RULES

#### NO PURCHASE NECESSARY TO ENTER OR WIN.

This sweepstakes ("Promotion") may only be entered in or from the 50 United States and the District of Columbia.

1. How to Enter. To enter, visit <https://allianceconnection.com/mindbodysol/> ("Website") to fill out and submit the entry form (the "Entry Form"). All entrants must have a valid email address. Entrants must enter all items in the Entry Form. Each entrant will get one (1) entry per person/household. No automated entry devices and/or programs permitted. All entries become the sole and exclusive property of the Sponsor (as defined below) and receipt of entries will not be acknowledged or returned. Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, misdirected, technically corrupted, or garbled entries, which will be disqualified, or for problems of any kind, whether mechanical, human, or electronic. Only fully completed Entry Forms are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor.

2. Eligibility. 4. Random Drawing/Odds. On or about February 5, 2024, Sponsor will select a potential winner to win the Prize (as defined below) in a random drawing from all eligible entries. Odds of winning depend on the number of eligible entries received for the drawing.

5. Prize. One (1) prize is available, consisting of one (1) four (4) day / three (3) night trip for the winning entrant (the "Winner") and one (1) adult guest of the Winner's choosing (the "Guest") to the Resort from March 7, 2024 to March 10, 2024 (the "Retreat Window"), which includes:
